III. Approval of the Minutes from September 12, 2024

 - 1. Timeline for rising 6th graders, 7th graders, 8th graders
 - a) Feb teacher recommendations for science, social studies, reading
 - b) March course selection starts

 - 2. Timeline to high school
 - a) Jan. teacher recommendations
 - II. New credit guidelines

III. Milestone data

- 1. School improvement plan is centered on being safe, connected, and thriving
- 2. Georgia Dept of Education website
 - a) CCRPI scores report as lagging indicators:
 - (1) 2023 100% on closing gaps
 - (2) 2024 shows 1,290 enrolled with 72% on closing gaps, 91% on content mastery, 82% on progress, 91% on readiness
 - (a) Drop in closing gaps is noted as possible correlation with rising enrollment of lower income families by Desana
 - (b) Drop in progress is relative to previous year
 - (c) Readiness score is based on student attendance, milestone scores
- 3. Desana Milestone Report (handout) for 2017-2024
 - a) Pre- and post- COVID trends
 - b) School support
 - (1) Breakfast club before school to give students more support
 - (2) After school support for non-English parents
 - (3) Reading class and lounge area to encourage student interest in reading

IV. Principal Report

- 1. Safety
 - a) As pilot rollout, Brandywine and Desana teachers now wear neck bands with audio enhancement (Safe Alert system) as location tracking microphone for live audio feed in emergency health or intruder incidents
 - b) Classrooms optionally has same microphone
 - Alternative alert options available but have reported many false emergency alerts
 - d) Safety reports derived from student participation in climate score, from student attendance
- Al (artificial intelligence) impacts on student cheating and other misuses will soon update DeSana's school handbook. Please read and send feedback.
- 3. Enrollment continues to grow so will prompt more staffing
 - a) DL (dual language program)
 - b) AP (assistant principal)
- 4. Denmark has land for new school but no announced plans yet
