- V. New Business
 - I. Matt presented SPLOST 6 Facilities Department
 - 1. Penny sales tax collected monthly
 - a) 40% of 300 million projected total come from people who don't live in Forsyth but shop here
 - 2. Currently on 6th iteration of previous educational tax
 - 3. SPLOST over the years pays only for things (buses, computers, etc) not for staffing
 - a) If no SPLOST then mileage rate may need to increase to offset costs
 - b) New construction for Poole's Mill Elementary, Hendrick's Middle School, New Hope Elementary School

- c) Renovations, modifications, additions for classrooms, cafeteria, etc
- d) SPLOST 6 only new school is Midway Elementary; rest goes to renovations of old schools as 5 year plan for board approval
- 4. SPLOST 7 in draft (May/June communications) for new schools in North Forsyth and additions to current schools based on 5 year projections of growing feeder schools

II. Principal Report

- 1. Milestone testing April 26 for 6th graders ELA/Math, April 24-May 2 8th grade all 5 subjects, May 5-7 for 7th graders
- 2. CCRPI report from 2024 rated DeSana at 93.40
- 3. PBIS is positive behavioral intervention system for students. Progress in training teachers and staff, created "Dragon Way" matrix as school-wide expectations, results include 21% decrease in principal interventions
 - a) Mostly funded by PTO
- 4. Chromebooks for all students possible next year, April 14 Disconnect to reconnect Event at Focal for parents
